Notice of the creation of new access roads from 8 April

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM. In your area, we are working near the A452, A45 and M42, which surround the site of the new Interchange Station.

We're preparing for our future construction works

To help us safely carry out our future construction works in your area, we need to create four new access roads surrounding the site of the new Interchange Station. These roads will tie into the existing road network and connect to haul roads on HS2 land, for the exclusive use of our construction vehicles. These new routes will reduce the requirement for traffic management in the future and help to alleviate congestion.

From April onwards, we will also begin to construct a number of small site compounds on HS2 land. Their development will have no impact on the existing road network.

We'll be starting work on 8 April

We'll be carrying out temporary daytime lane closures, at four locations, from Monday 8 April to Wednesday 26 June (see maps on next page). Our working hours will be 9.30am to 3.30pm, but our contractors may be on site up to an hour before and after those times.

We have planned daytime lane closures

We are planning temporary daytime lane closures on:

- A452: 8 April to 31 May
- B4438: 15 April to 24 May
- A446 Southbound: 23 April to 29 May
- A446 Northbound: 29 April to 26 June

Duration of work

From Monday 8 April to Wednesday 26 June.

Working hours will be 9.30am to 3.30pm, but our contractors may be on site up to an hour before and after those times.

What to expect

Temporary daytime lane closures on the A452, B4438 and A446.

The creation of four new access roads in the area.

What we will do

Keep all sites safe and secure.

Ensure that the contractor's vehicles use agreed routes.

Leave the area in a tidy state when works are complete.

Location of lane closures in your area

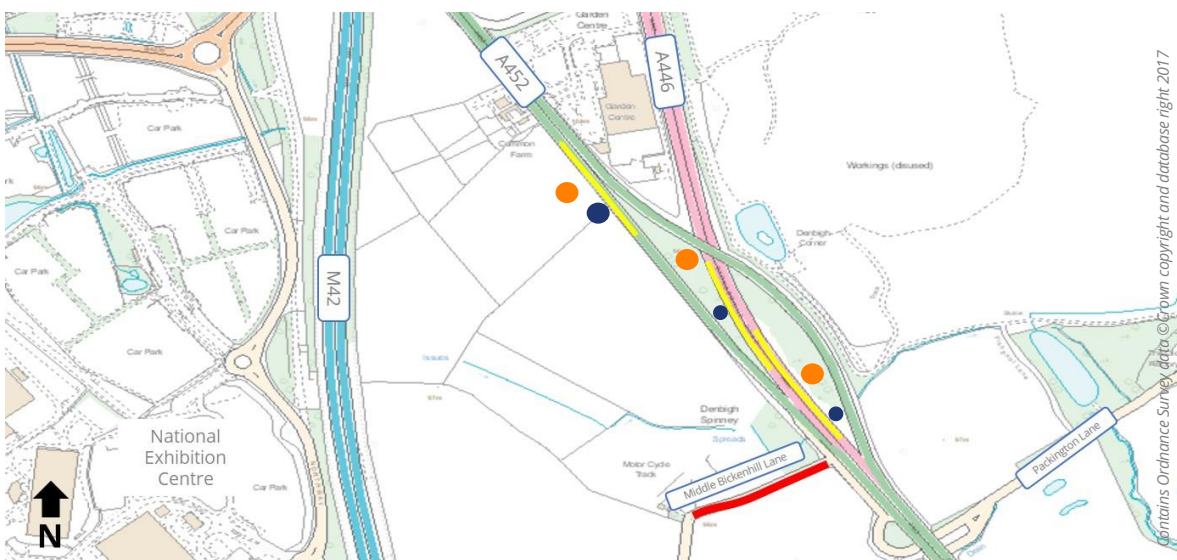
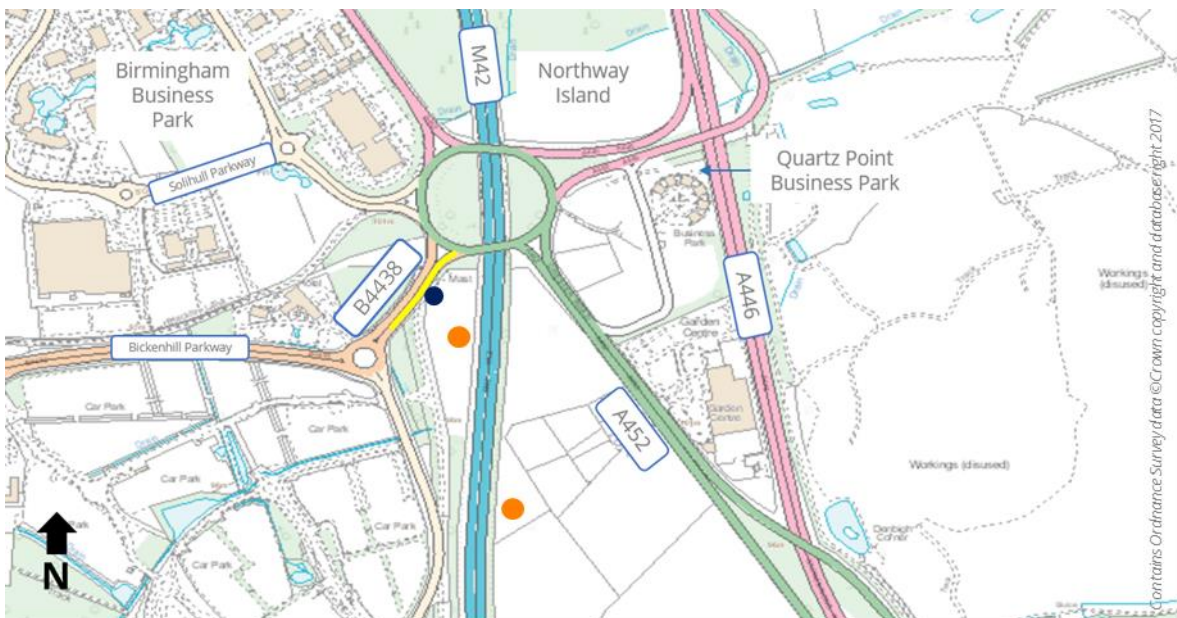
Key:
